Report / Action Required

- There were apologies for absence received from Cllrs Nick Gilbert, Cllr Kath Potter (Peak Park), PC 1. Shaun Jakins and PCSO Anthony Boswell.
- 2. There were no declaration of interests.
- 3. Public speaking:
 - June Powell Chairman of Baslow Senior Citizen's concerned about the Christmas Markets. Raised with the everyone. The markets have a huge impact on the ability to run Senior Citizens in the Village Hall. The Christmas Markets are being discussed later on the agenda and Mrs Powell said she would stay to listen.
 - Cllr Susan Hobson:
 - Local Gov reorganisation. DCC put forward their proposal Derbyshire and Derby City. The District Councils want 2 authorities - a North and South. Ultimately the government will decide what to do. Cllr Dawson - In November they have to put in the views of the local tiers and how councils may be merged. Should we not discuss this and decide what the Parish Council want? At this moment in time, it is too early to be able to look at that. Discussion about South Darley trying to be merged with Matlock. Who should we be merged with if a merger is going to happen. DDDC is meeting tomorrow night to look at their proposal.
 - Potholes seem to be being caught up. Eaton Hill was repaired this week.
 - District Council funding for VE day. Only for PCs not Parish Meetings.
 - Funding has been granted from the Mayor to open Chesterfield Road in Beeley within the next 2 years. This will reduce traffic coming through Baslow to get towards Chesterfield.
 - DDDC has put forward a planning application for Rowsley Car Park for a temporary traveller site. No note on the application that it is seasonal, just says 2 years.
 - Hulleys buses no direct effect on buses through Baslow but the 172 funding has been withdrawn by DCC due to inability to deliver the service.

- 8. Suggestions or issues from residents:
 - A621 Sheffield Road, Baslow. Speeding Speeding has been monitored and awaiting the data. Derwent Drive had radar trap today. This was all noted.
 - Signage on Over Lane There is a sign on Over Lane with the junction to Over Road. This has reduced large unsuitable traffic entering the lane from Over Road. However, traffic is still coming in from the shop end. It was agreed to ask a resident if they would allow a sign on their wall.

Electric charging points in the village - Approached by a resident about whether there are any plans for charging points. DDDC are looking at putting in points in the car park. Grindleford are looking at points on the side of the road and are working with a company to develop this. The Village Hall or Sports Field would be good locations and then this generates income for the facilities. Potential customers are local residents who want to have electric cars and then visiting people who want to see the area. It is not cost efficient for residents as 10x more expensive than charging at home. The weir generation project is progressing and funding being applied to develop further.

- 9. Inspections
 - Issues from latest inspections?
 - Burial Ground No issues. Cllr Dawson will continue to inspect.
 - Request for a new plot from the Sheldon family The background was explained. The Sheldon family are a previous family of the village. In 2015 Mr and Mrs Sheldon were granted a plot due to the strong family ties. Their daughter has now requested another plot for her sister and her to use. Following a discussion it was agreed not to grant this request.
 - Woodland Discussed under Item 10
- 10. Working Party and General Updates:
 - Woodland Working Party
 - Woodchip Has been completed.
 - Fence removal and replacement Mentioned to Anthony Boswell. It was agreed to leave the den and remove the fire stones. Nature of the play is different between the 2 areas. Parents with small children like to know they can't get to the nature area. Rospa will expect the areas to be fenced. Play area different to woodland play and needs separating. The majority of Councillors agreed to a new fence being installed.

Bike track area - request for a community classroom. There was a discussion about the options and it was suggested that a meeting is held with the Parish Council, Sports Field and school.

KBB being one of them. Its remit was widened to include the history boards, 20s plenty and monitoring the work done by the District Council. It was felt that this would be disbanded. It was agreed by all and Cllr Dawson will inform the resident on the group.
